You should take special care to prevent violations, such as, but not limited to, exchanging cash for SNAP benefits, accepting SNAP benefits from unauthorized individuals, the sale of ineligible items, the acceptance of SNAP benefits on credit accounts, and the acceptance of SNAP benefits for repayment of cash loans. You are responsible for any violations committed by employees working in the store.

1. **Ensure there are no other shipping or tracking labels attached to your package.** Select the Print button on the print dialog box that appears. Note: If your browser does not support this function select Print from the File menu to print the label.
2. **Fold the printed label at the solid line below.** Place the label in a UPS Shipping Pouch. If you do not have a pouch, affix the folded label using clear plastic shipping tape over the entire label.
